**(a) Deleting the footpath**

from: a point (point A on the map) to the NW of the metal farm gate which, prior to 1984, was part of an estate access track to Killiganoon Manor

to: the point (point B on the map) at which the recorded route of FP18 joins the existing footpath shown running along the NE edge of the adjacent field (to the west of Killiganoon Manor)
