Schedule of Claimed Public Footpaths

Glendorgal Headland – Definitive Map Modification Order Application

This application seeks the addition of the following public footpaths to the Definitive Map and Statement, as shown on the accompanying application plan.

Route 1 – Main Route (Red)

A public footpath extending between **Great Cupboard Steps** (Grid Reference **SW 82531 62780**) and the **Lusty Glaze car park entrance** (Grid Reference **SW 82482 62519**), following the route shown in **red** on the accompanying application plan.

Route 2 – Cross Headland Route (Yellow)

A public footpath following the route shown in **yellow** on the accompanying application plan, extending between Grid Reference **SW 82482 62779** and Grid Reference **SW 82401 62729**.

Route 3 – Wine Cove Steps (Purple)

A public footpath following the route shown in **purple** on the accompanying application plan, extending between Grid Reference **SW 82365 62747** and the beach at **Wine Cove** via the existing hewn stone steps.

Route 4 – Lusty Coast Route (Turquoise)

A public footpath following the route shown in **turquoise** on the accompanying application plan, extending between Grid Reference **SW 82391 62698** and Grid Reference **SW 82384 62645**.
