HIGHWAYS ACT 1980 - PUBLIC RIGHTS OF WAY

The Forestry Commissioners on behalf of the Minister of Agriculture Fisheries and Food wish to deposit a map under Section 31(6) of the above Act in order to negative any intention to dedicate new rights of way over land vested in the Minister. The map will be based on the current definitive map published under the provisions of the National Parks and Access to the Countryside Act 1949.

As you know, this section of the Act is not binding on the Crown unless by Section 327 the appropriate authority (in this case the Minister) in relation to any land agrees with the highway authority that Section 31(6) of the Act shall apply to such land. I would be grateful if you would confirm that your Council is prepared to enter such an agreement.

HIGHWAYS ACT 1980 NOTICE

The Minister of Agriculture, Fisheries and Food hereby deposits with Cornwall County Council the accompanying maps on which the land vested in him and placed at the disposal of the Forestry Commissioners in the County of Cornwall is shown delineated in pink.

The Minister of Agriculture, Fisheries and Food admits that the ways shown on the said map by orange for footpaths and green for bridleways are public rights of way within the provisions of Part IV of the National Parks and Access to the Countryside Act 1949. The Minister of Agriculture, Fisheries and Food denies that there are any other such public rights of way over the land vested in him and shown on the said map.

For the purpose of this notice the Minister of Agriculture, Fisheries and Food and the Cornwall County Council hereby agree that sub-section (6) of section 31 of the Highways 1980 shall apply to the land vested in the Minister of Agriculture, Fisheries and Food and shown delineated pink on the said map.

For the purpose of this notice THE MINISTER OF AGRICULTURE, FISHERIES AND FOOD and the Cornwall County Council hereby agree pursuant to Section 327 of the Highways Act 1980, that sub-section (6) of Section 31 of the Highways Act 1980 shall apply to the land vested in THE MINISTER OF AGRICULTURE, FISHERIES AND FOOD and shown edged green on the said maps.
