EDGED RED. (DATED MAY 2002.)

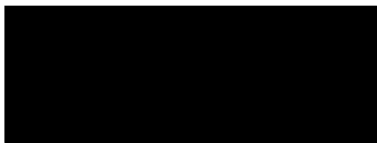
ON THE 6th OF JUNE 1996, WE DEPOSITED WITH THE
