

 WE Michael Roy Hampden-Smith and Merylyn Hampden-Smith DO SOLEMNLY AND SINCERELY DECLARE as follows:

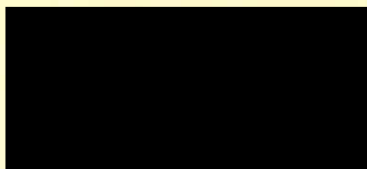

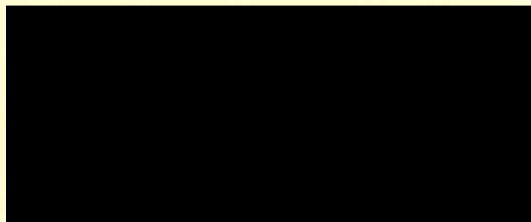
