HIGHWAYS ACT 1980 SECTION 31 (6)

I WENDY HIGLETT DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 12th July 1976 the owner of the land known as Shute Wood, Trevellas, St Agnes, Cornwall, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 5th day of May 1995 my predecessor Laura H Judson deposited with Cornwall Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that no ways had been dedicated as highways over our property.

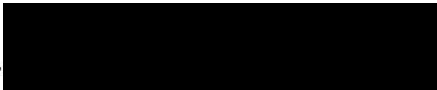

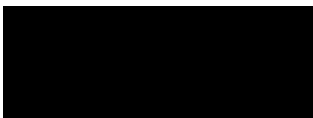
