- 1. I am the Chief Land Agent of the Cornwall County Council ("the County Council") and make this declaration on behalf of the Council pursuant to the provisions of Section 31(6) of the Highways Act 1980 in respect of Laity Farm Bridge Redruth Cornwall ("the Property") part of which is more particularly shown edged red on the plan now produced to me and marked "BRF1" ("the Plan")
- 2. The County Council has been in ownership and possession of the Property since 20th October 1904
- 3. On 20th April 2004 the Chief Land Agent & Valuer of the County Council deposited with the County Council, being the appropriate Council, a statement accompanied by a plan delineating part of the Property stating that the ways coloured brown on the Plan were dedicated as highways with vehicular status and the ways coloured purple on the Plan were dedicated as footpaths and that no other ways over the land shown on the Plan have been dedicated as highway
- 4. Since 20 April 2004 I can say that no additional ways have been dedicated over any part of the Property shown edged red on the Plan and at the present time there is no intention of dedicating any more public rights of way over any part of the Property shown edged red on the Plan
- 5. I depose as above of my own knowledge as Chief Land Agent for the County Council
