Statutory notice of negative intention to dedicate under section 31(6)  
of the 1980 Highways Act.

I hereby give notice that I am the owner of the land edged red on the enclosed plan, and that it is not my intention that any right of way should arise on my land.

I further give notice that I am the owner of the land edged in green, and that it is not my intention that any right of way should arise which is wider than Garner's "single file on open land". I specifically give notice that no fences, trees, walls, posts, or any other feature erected by myself or previous owners to control livestock or provide privacy, whilst allowing vehicular access from my garage, should be regarded as indicative of the width of any footpath thereon.

Dear Sirs,

I hereby give notice that I am the owner of the land edged red on the enclosed plan, and that it is not my intention to allow any further rights of way to arise on my land. (Section 31.6 Highways Act 1980). I also give notice that I do not intend the width of the right of way where it crosses my field at C to be wider than the statutory minimum, and that any walls or fences erected there are for the purposes of enclosing my chicken run and preventing public access to my property, whilst allowing sufficient width for vehicular access to my garage at A, and are unconnected with the right of way. 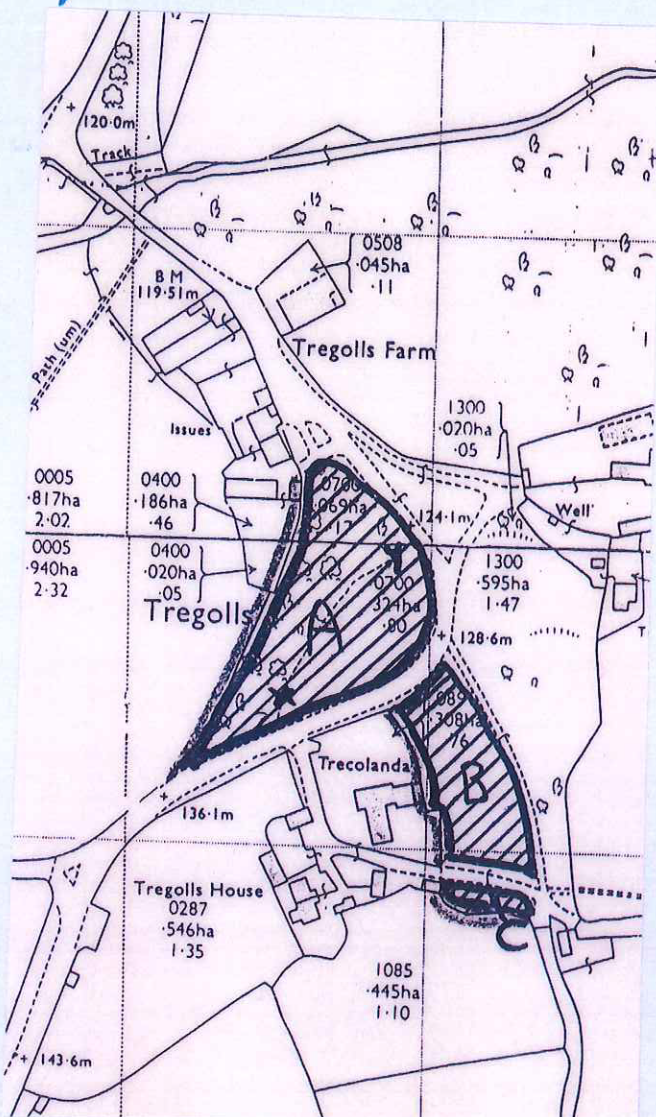
