**STATUTORY DECLARATION OF LANDOWNER

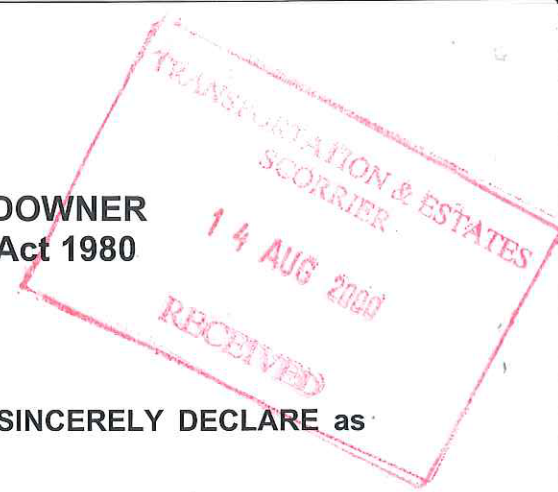
